About the Nauru Citizenship Program

Nauru is a tiny island nation in the Pacific Ocean, one of the smallest and least populated independent countries worldwide.

The country spans just 21 km² and is located on a single island in the western Pacific, near the equator, with Kiribati as its nearest neighbour. Nauru has no standing military, and Australia provides its defence under a long-standing agreement. The island's pristine coral reefs and untouched waters make it a paradise for divers and nature enthusiasts.

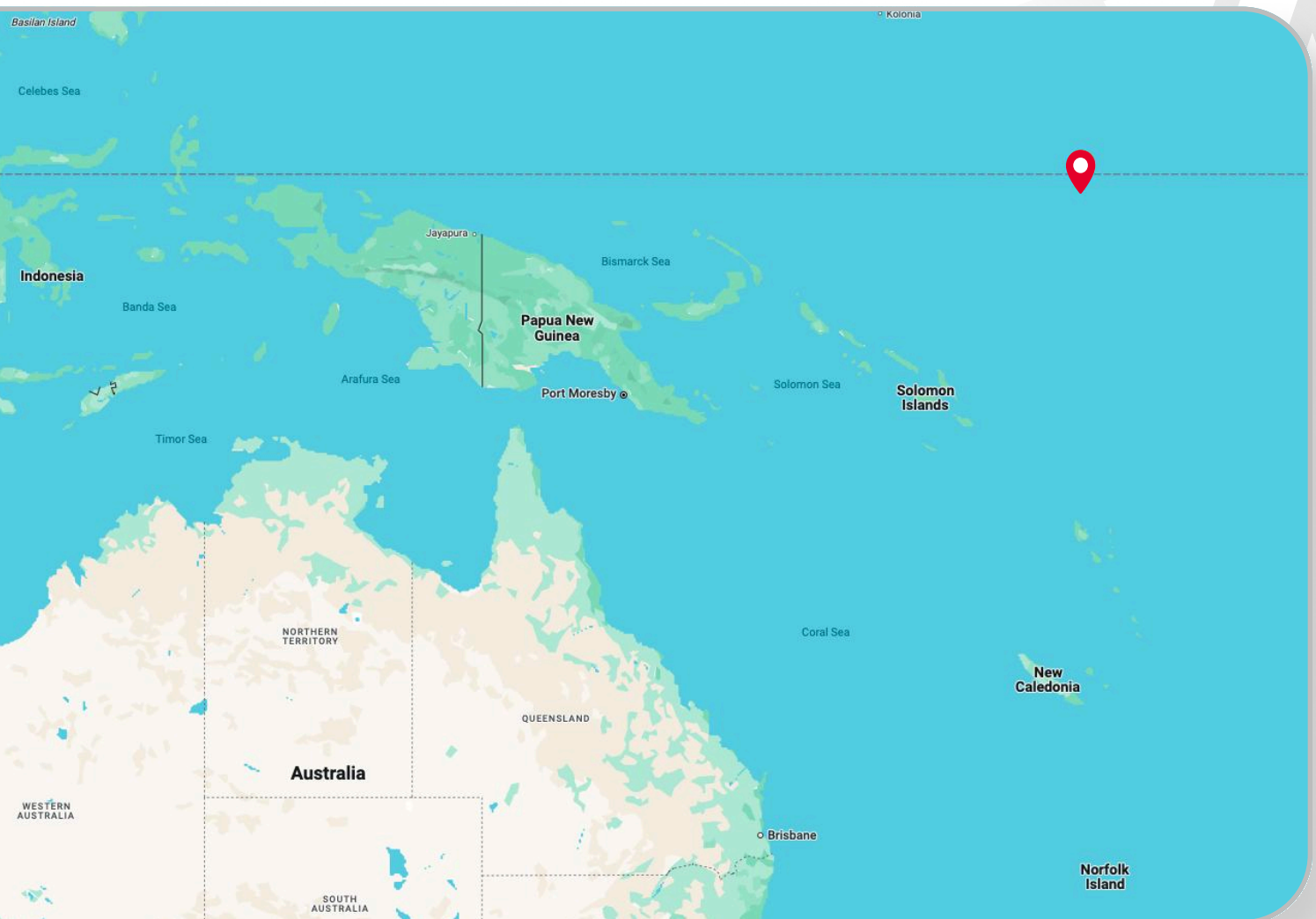
At the end of 2024, the Government of Nauru launched its Citizenship by Investment Program, which is legally based on Nauru Act No. 15 and aims to support economic growth and climate resilience.

The Nauru Citizenship by Investment Program allows high-net-worth investors and their families to obtain second citizenship by making a non-refundable contribution to the Treasury Fund. The invested funds to support national development goals, including environmental initiatives, public services, and infrastructure improvements.



Geography and Climate

The oval island has an 18-km coastline. Nauru has no official capital; its administrative offices and parliament are in Yaren District. The climate is equatorial monsoon, characterised by hot and humid conditions. The rainy season lasts from November to February, although dry periods also occur.



History

The island was settled by Micronesians and Polynesians around 1000 BCE. In 1888, Germany annexed Nauru. After World War I, governance of the island was transferred to Australia, New Zealand, and the United Kingdom. During World War II, the island was occupied by Japan, and after liberation, it was returned to the Australian administration. Nauru gained independence on 31 January 1968.

Economy

Nauru's primary natural resource is phosphate, which was extracted in the early 20th century. Due to phosphate exports, the country had one of the highest per capita incomes in the world during the 1970s and 1980s. However, resource depletion led to economic difficulties and environmental challenges. Today, Nauru's economy is supported by revenue from fishing licences and international aid, particularly from Australia and Taiwan.

Population & Culture

The majority of the population consists of Nauruans of Micronesian descent. The official languages are Nauruan and English.

International Relations

Nauru has been a member of the Commonwealth of Nations and the United Nations since 1999. The country maintains diplomatic relations with several nations, including Australia, the United Kingdom, India, Taiwan, and the United States.



Investment Requirements for Nauru Citizenship

from \$90,000*

To qualify for the Nauru Citizenship by Investment Program, applicants must make a non-refundable donation to the Treasury Fund. The required contribution amount depends on the number of individuals in the application.

From 30 January to 30 June 2026, a special offer applies under the Iruwa Initiative, introducing a reduced entry threshold for the programme. Outside this promotional period, the minimum investment requirement is USD 115,000.

Eligibility Criteria for Nauru Citizenship

To apply for citizenship under the Nauru Citizenship Program, the main applicant must:

- Be at least 18 years old at the time of application.
- Make or intend to make the required investment in the Treasury Fund.
- Meet the program's eligibility requirements, including not holding citizenship of a restricted country.

The main applicant may include dependents, such as:

- **spouse**;
- **children** of the main applicant or of the spouse, of any age;
- **parents and grandparents** of the main applicant or of the spouse, of any age;
- **siblings** of the main applicant or of the spouse, of any age.

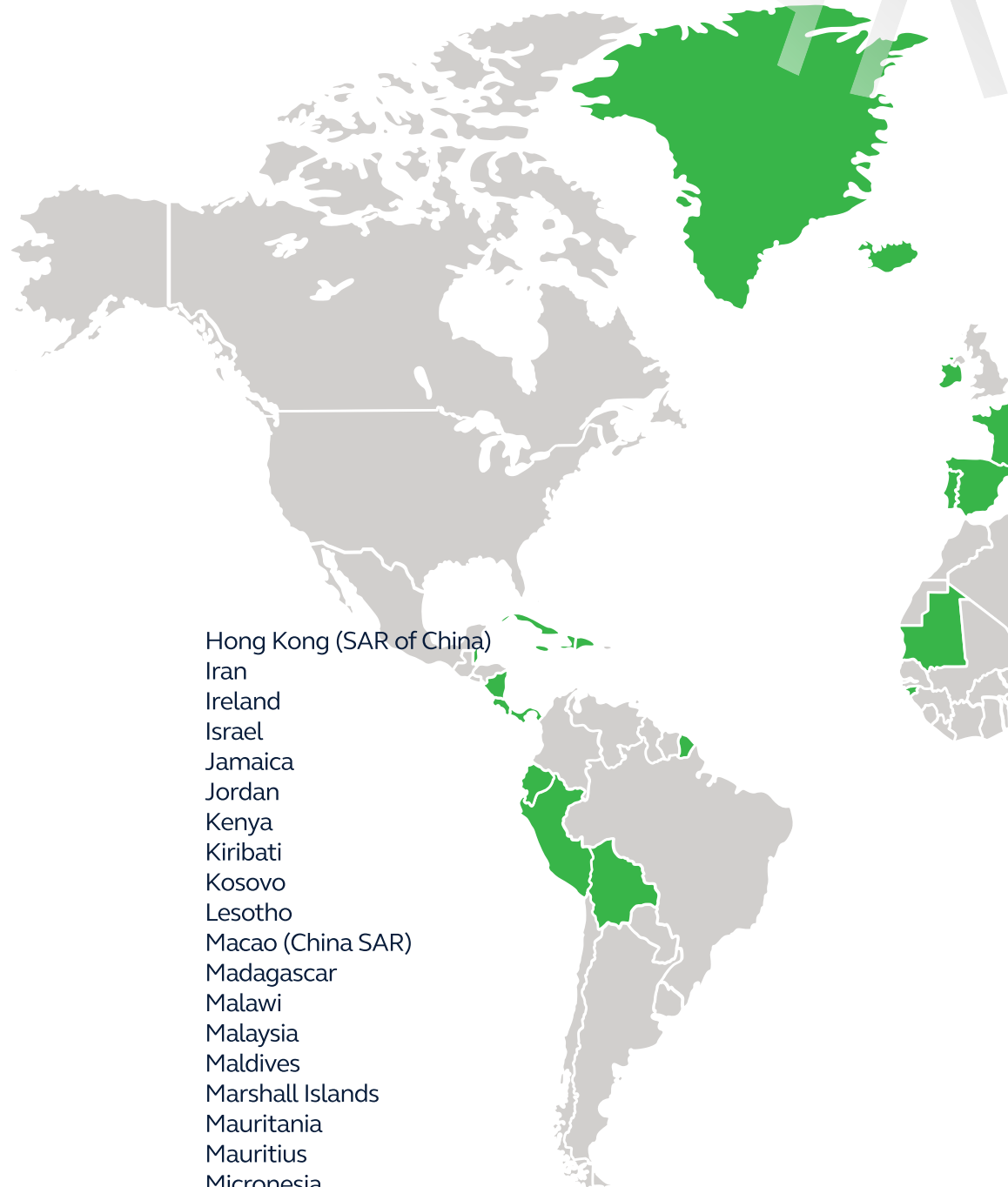

The applicant and family members receive their Nauru passports.
