Other options include contribution in an approved enterprise project for a minimum of **\$250,000** or investing in government bonds from **\$350,000**.

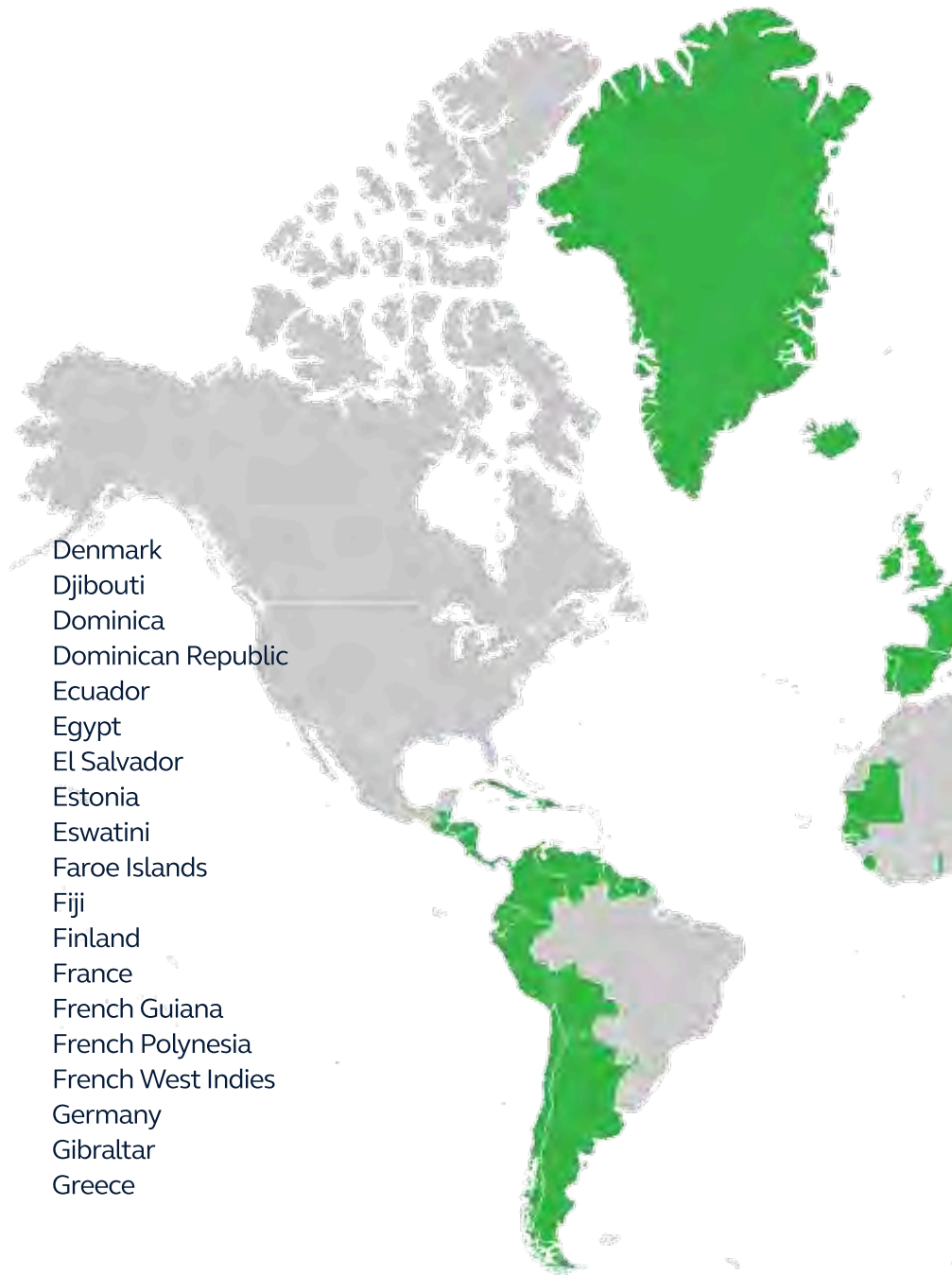

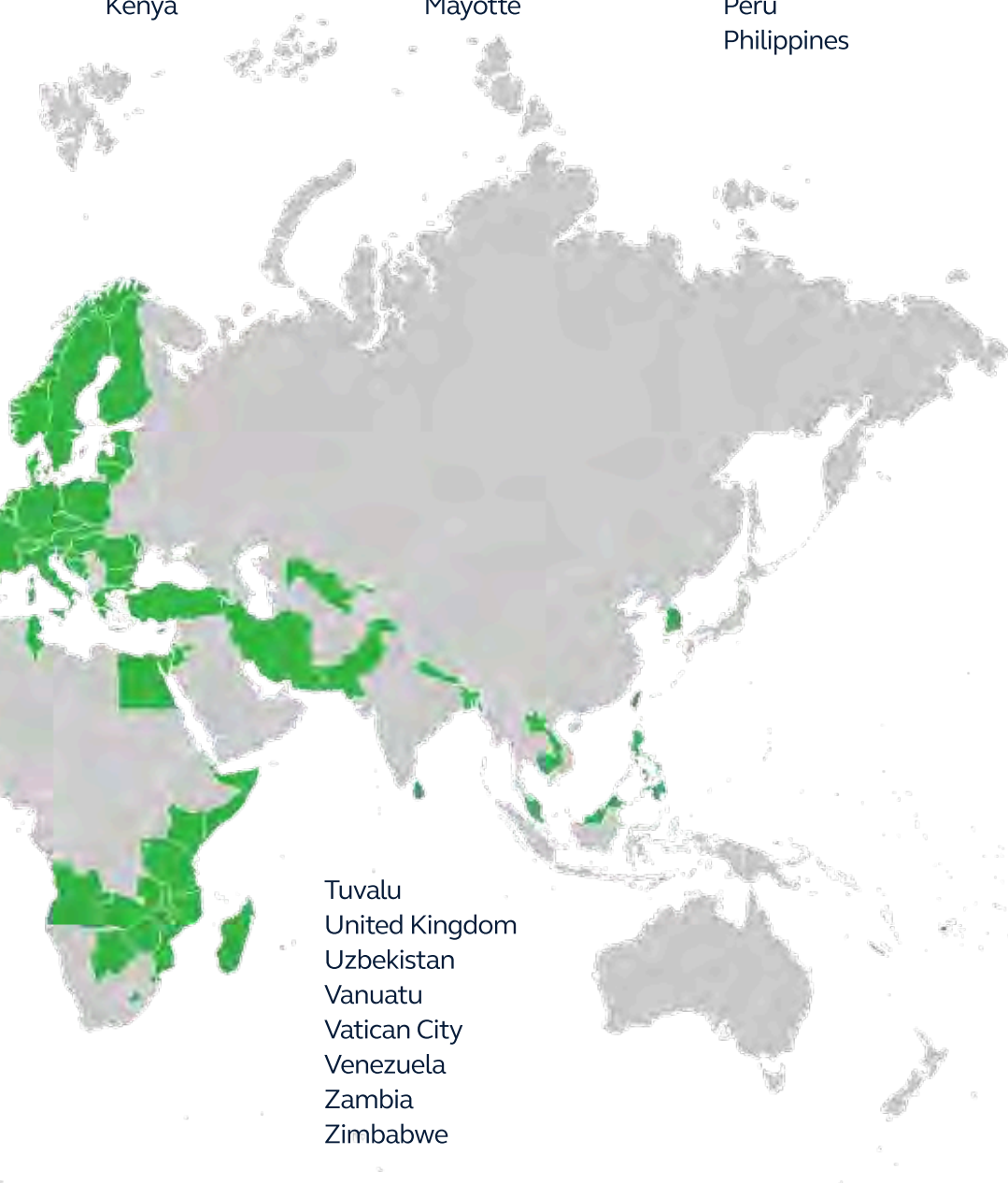

Saint Lucia Citizenship Acquisition Process



Who is eligible?

- Main applicant
 - The primary applicant must be 18 years of age or above
 - The applicant must have a clean criminal record
- Children, including dependent children up to the age of 25
- Spouse
- Dependent parents over the age of 55
- Siblings of the main applicant under 17. Unmarried. Must receive consent of parent / guardian.
