# About the Vanuatu Citizenship Programme

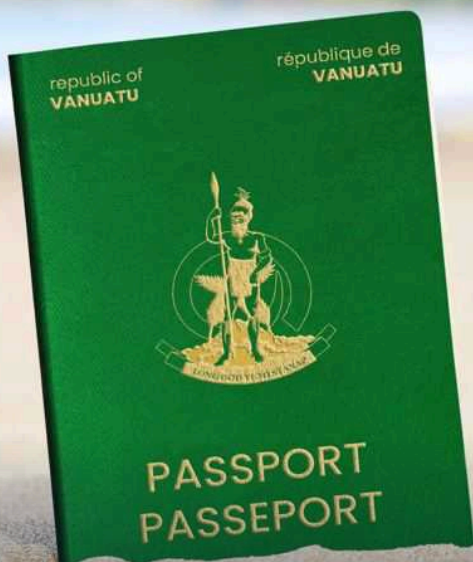
The Vanuatu Citizenship-by-Investment Programme — the only one of its kind in Oceania — was launched in 2017 to attract high-net-worth investors worldwide.

**The programme plays a key role in Vanuatu's socio-economic development.**

Investment funds are allocated to upgrading public hospitals, road maintenance, and disaster relief efforts, addressing the region's frequent natural catastrophes.

The citizenship-by-investment programme contributes an average of 18% of the government's annual revenue. In 2024 alone, the programme generated \$60 million in investments.

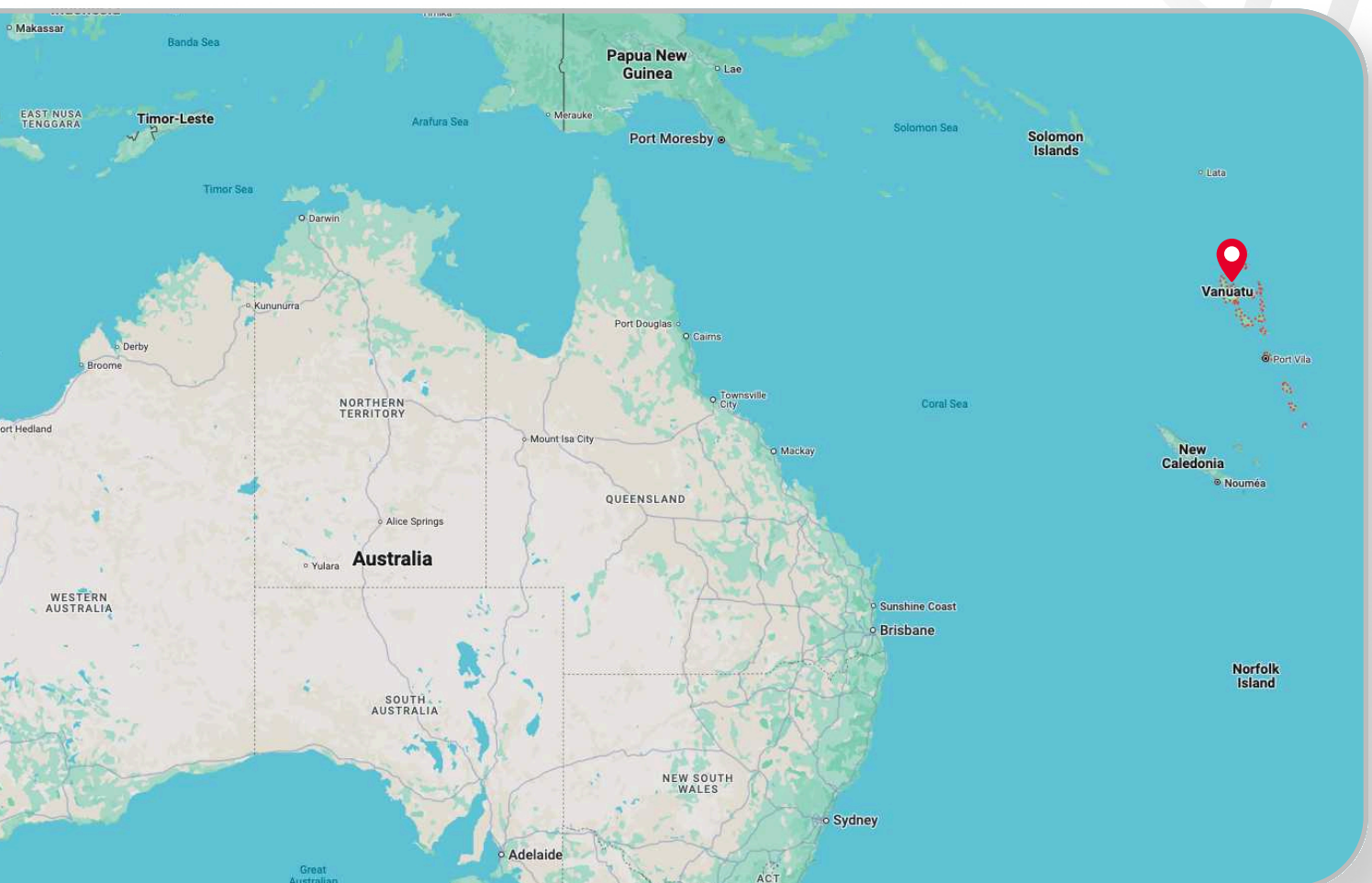
Vanuatu's strong appeal to international investors is due to its affordability and efficiency, making it **the world's fastest and most cost-effective citizenship-by-investment programme.**



# Geography

The Republic of Vanuatu comprises over 80 islands in the Pacific Ocean, located near Australia, Fiji, and New Zealand. Its land area is 12,000 km<sup>2</sup>. With a population of approximately 300,000, most residents are unevenly distributed across the islands.

6% of the population resides in the capital, Port Vila, and Luganville, the second-largest city. More than 65% of residents live in rural areas, though urban migration is steadily increasing.



# Happiness Index

**In 2006, Vanuatu ranked as the world's happiest country; in 2019, it secured second place.** Researchers attribute this to strong community ties, active social engagement, and a deep connection with nature. The country enjoys a high safety level, a peaceful foreign policy, no standing military, and extremely low crime rates.

## Economy

**Vanuatu has successfully preserved its traditional way of life and unspoiled natural environment while also emerging as a leading offshore financial hub.** The country attracts foreign entrepreneurs with its low tax burden and relaxed financial reporting regulations. The citizenship-by-investment programme also plays a key role in attracting international capital.

## History

**Vanuatu gained independence in 1980. Vanuatu means «Our Land Forever» in one of the local languages.**

From 1906 to 1980, the New Hebrides (Vanuatu) was a joint colony of France and the United Kingdom. English and French remain equal official languages, alongside Bislama, a Melanesian dialect with English influences.

## Religion & Culture

Traditional indigenous spiritual beliefs coexist with Christianity and other unique religious practices on the islands.

A legacy of British rule is the widespread popularity of football, cricket, rugby, and other outdoor sports. Vanuatu's national soccer team is a member of FIFA. The national athletics team has participated in almost every Summer Olympics since 1988.

## Nature & Ecology

Vanuatu boasts a diverse natural landscape, featuring mountains, active volcanoes, pristine tropical rainforests, white sandy beaches, and crystal-clear waters.

Even on inhabited islands, towns and villages are concentrated along the coastline, while untouched rainforests and mountain ranges dominate the interior.

The country has no large-scale industries or polluting activities, preserving its pristine ecological balance. The Vanuatu government actively promotes environmental sustainability, continuously working on enhancing its green initiatives.



# Requirements for Obtaining Vanuatu Citizenship by Investment

The citizenship application process typically takes between 1 to 3 months.

To participate in the Vanuatu Citizenship by Investment Programme, applicants must choose one of the following investment options:

- Investment in the Development Support Program (DSP)
- Investment in the Capital Investment Immigration Plan (CIIP) – Cocoa Development Fund (CDF)

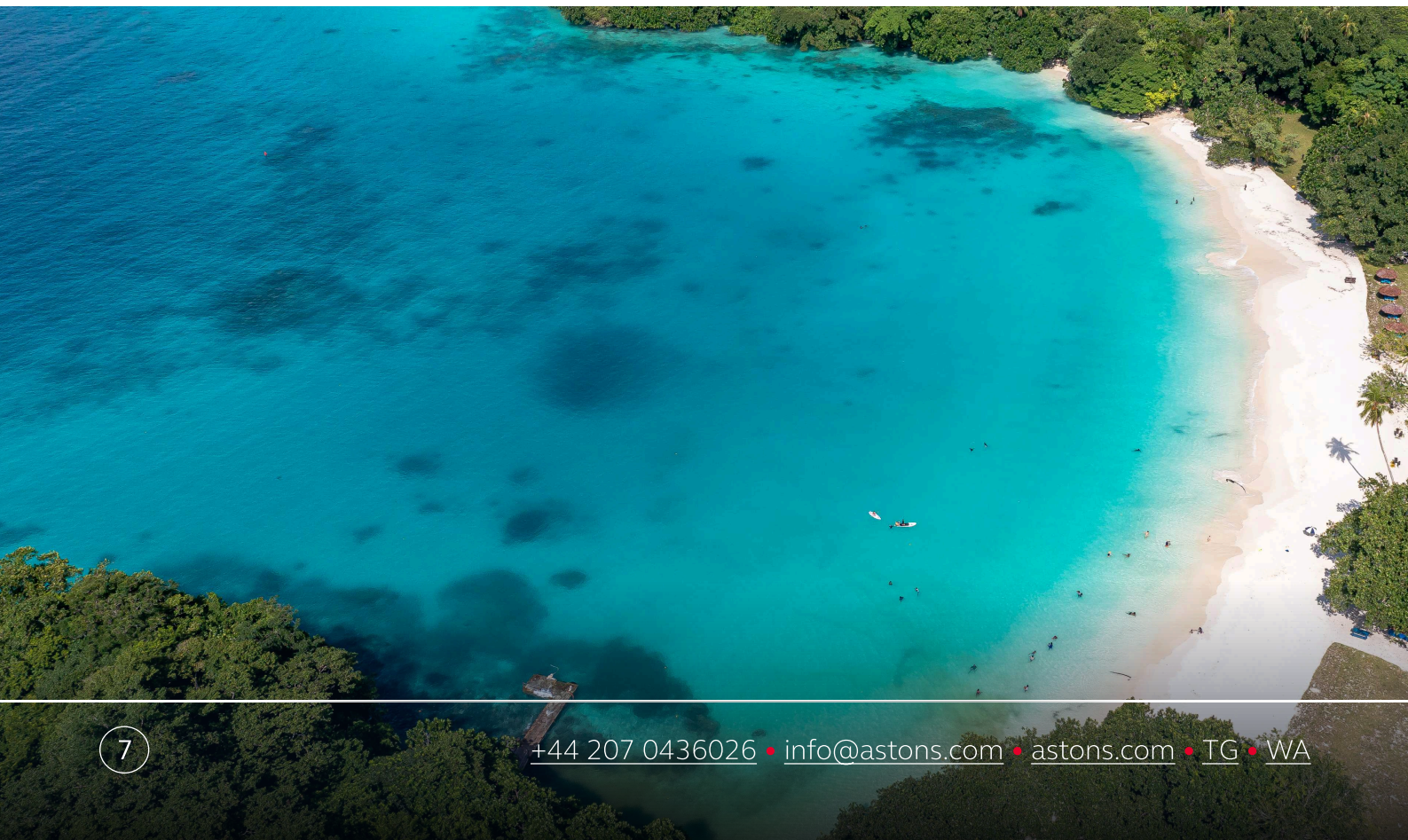
# Additional Requirements

**To be eligible for the Vanuatu Citizenship Programme, the applicant must:**

- Be over 18 years old
- Have no criminal record (must provide a police clearance certificate from the country of residence)
- Provide proof of financial assets or funds of at least \$250,000
- Not be listed on any international sanctions lists

## **Citizenship for the Whole Family**

Vanuatu is one of the few countries offering citizenship by investment that allows applicants to include not only a spouse and children (up to 28 years old) but also parents, grandparents, or great-grandparents.



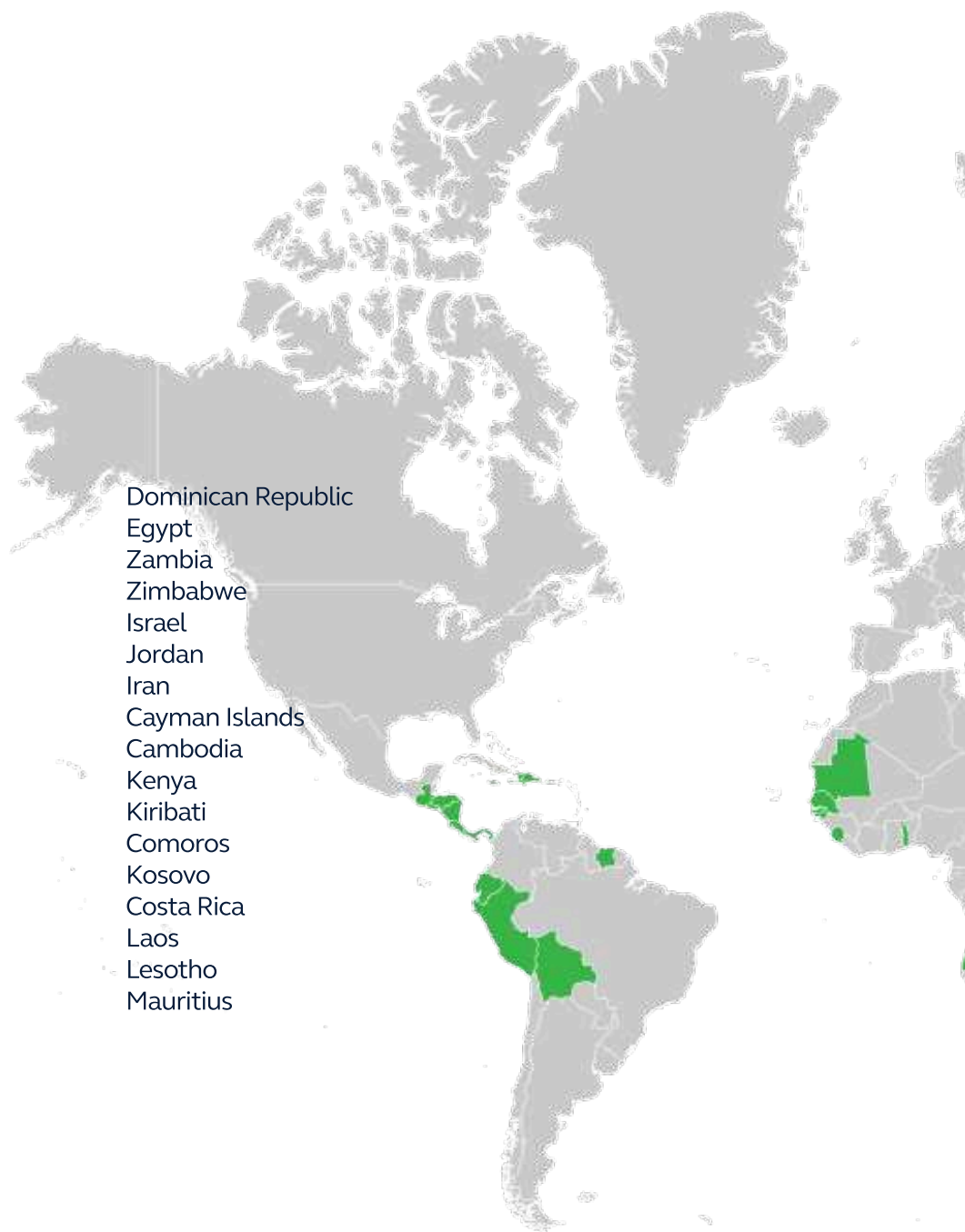
# Visa-Free Access to 90+ Countries

Travel the world with a Vanuatu passport and enjoy visa-free access to numerous destinations, including Hong Kong and Singapore.

Visa-free access to the Schengen Zone for Vanuatu citizens was temporarily suspended in May 2022. Travelling to the Schengen Zone, the United Kingdom, or the United States requires a visa.

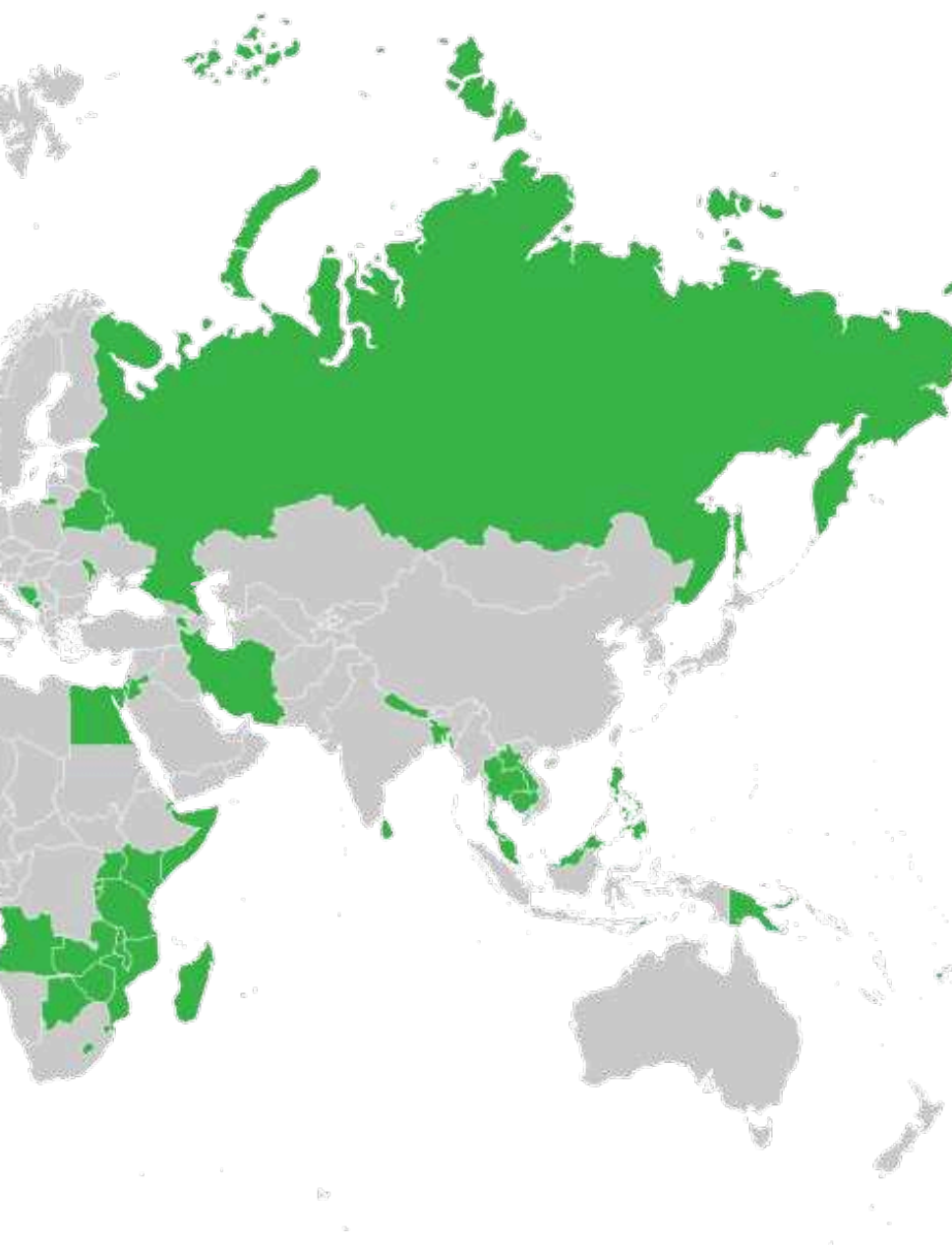

# Step-by-Step: How to Obtain Vanuatu Citizenship

## Preliminary Due Diligence Check

The Government of Vanuatu will conduct a comprehensive background check on the main applicant, and all adult family members in the application to confirm eligibility.

The investor must pay the due diligence fee of \$5,000 – \$5,500 per family for the Vanuatu Financial Intelligence Unit (FIU), depending on the selected investment option.

## Preparation of the Citizenship Application

Once the government grants preliminary approval, our experts will prepare the full citizenship application and all required documentation. The submission and review process takes approximately **30 days**.

4

## Investment in the Selected Fund

The investor must make an initial contribution of 25% of the total donation amount. The final donation sum depends on the family size and the chosen investment option.

5

## Application Processing & Final Review

Applications are submitted to the Government of Vanuatu and reviewed by the Citizenship Commission at its next scheduled meeting, which takes place twice a month. This stage typically takes **around 4 weeks**.

6

## Final Approval & Payment of the Remaining Investment Amount

Once your application is approved, the investor must pay the remaining 75% of the donation amount. Once the Vanuatu bank confirms receipt, the applicant will be invited to take the Oath of Allegiance.

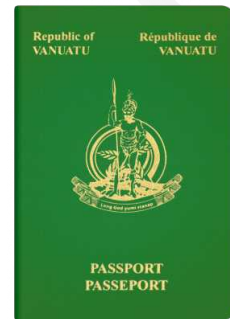
The oath ceremony can be arranged in any location worldwide or remotely for an additional fee.

## Issuance of the Vanuatu Passport

The applicant and their family will receive Vanuatu passports, granting visa-free access to over 90 countries.

Citizenship is granted for life, while the passport must be renewed every 10 years.



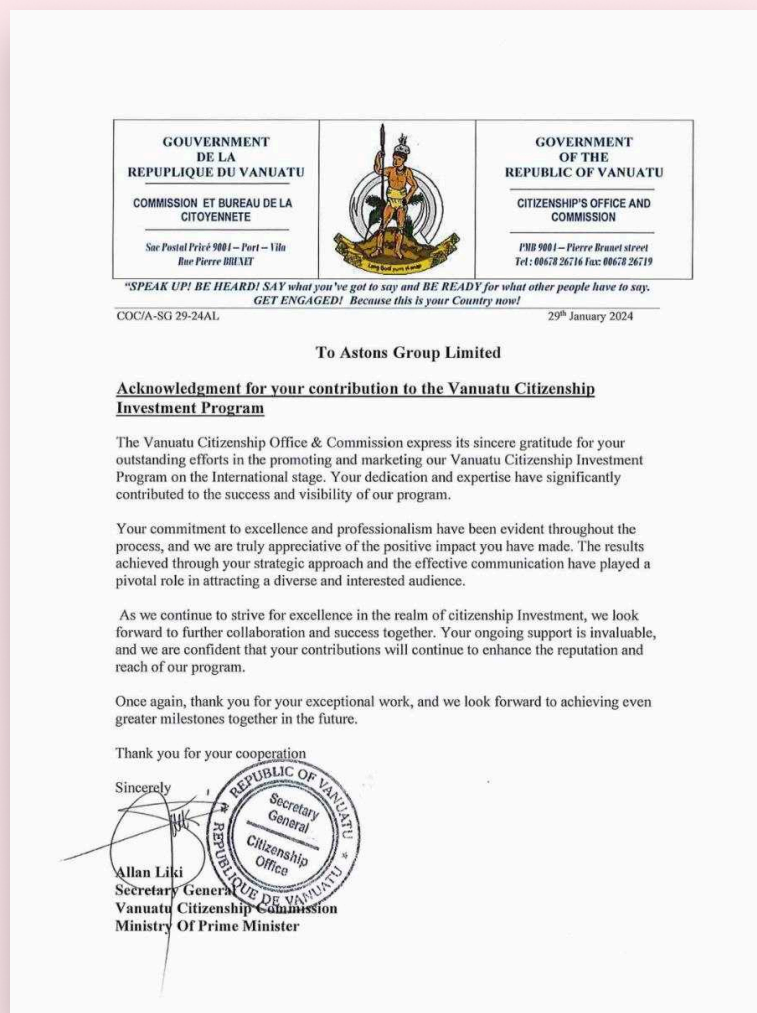
